The next meeting of the search committee will take place at 1:30 p.m., April 29, 2024 to prepare for the May 9, 2024 interviews. At the May 9, 2024 meeting the board of directors will be invited to attend the interviews and all questions previously collected and selected will be posed to the respective candidates by the lead interviewer only.

The May 9, 2024 board of directors meeting will take place at 2:00 p.m. to give the search committee time to complete the interview process. At the May 9, 2024, meeting the HR Search Committee will recommend to the board consideration of an executive session pursuant to CRS 24-6-402 (4) (e) & (f) to provide a recommendation of a candidate(s) and deliberate terms and conditions of a potential contract offer.

In the interim, letters will be sent to all applicants thanking them for submitting applications and advising those selected for interviews of the scheduling times for the respective interviews.
